The undersigned (Member/Co-Member) hereby makes application and agrees to purchase electric service from Fort Belknap Electric Cooperative, Inc., in accordance with the following terms and conditions:
 1. The applicant will pay to the Cooperative the sum of \$15.00 which will constitute the applicant's membership fee and \$75.00 per meter which will constitute the applicant's connect fee(s). For non-permanent or temporary service, the connect fee will be \$150.00 per meter.
 2. The applicant will pay to the Cooperative the sum of \$ _____ which will constitute the applicant's deposit for electric service. Upon termination of this agreement, any portion of the deposit not previously applied to any outstanding balance will be returned. The applicant may provide or promise a satisfactory Letter of Credit (excluding non-permanent residences) from a current electric provider to avoid the payment of a deposit. However, if a satisfactory Letter of Credit is not received by the Cooperative within 10 days, the security deposit amount will automatically be added to the account balance with no notification. The applicant's electric service may be discontinued if the Cooperative does not receive the deposit payment within 10 days after adding it to the account. It will be the applicant's responsibility to request and monitor the status of the Letter of Credit.
 3. This Electric Service Agreement shall continue in force for an indefinite period of time from the date of service is made available by the Cooperative to the member. This agreement may be terminated by either party giving notice.
 4. Member warrants that his or her installation (including all conductors, switches, equipment, wiring and protective devices of any kind) is constructed and will be maintained in accordance with the National Electrical Code as well as applicable laws or ordinances.
 5. Member agrees to pay for electric service in accordance with Cooperative's tariff and abide by the Cooperative's Articles, Bylaws and policies, as may be amended from time to time. Periodically, the Cooperative will submit to the member a statement of services rendered. Member agrees to pay the total amount shown on such statement within fifteen days from its date. Payment shall be made to the Cooperative at its office or through the Cooperative's accepted payment programs
 6. Upon failure to make payment or perform any obligation under this agreement, the Cooperative shall have the right to discontinue service or demand remedies as provided by law. The Cooperative's liability is limited as provided in its tariff.
