- 4. Member warrants that his or her installation (including all conductors, switches, equipment, wiring and protective devices of any kind) is constructed and will be maintained in accordance with the National Electrical Code as well as applicable laws or ordinances.
- 5. Member agrees to pay for electric service in accordance with Cooperative's tariff and abide by the Cooperative's Articles, Bylaws and policies, as may be amended from time to time. Periodically, the Cooperative will submit to the member a statement of services rendered. Member agrees to pay the total amount shown on such statement within fifteen days from its date. Payment shall be made to the Cooperative at its office or through the Cooperative's accepted payment programs
- 6. Upon failure to make payment or perform any obligation under this agreement, the Cooperative shall have the right to discontinue service or demand remedies as provided by law. The Cooperative's liability is limited as provided in its tariff.
